- Discuss how to handle 18 – hole golf finances - Mike Rothman

Mike Rothman made the following motion, and John Rexroat seconded: The BEC recognizes State SIR practice of allowing independent golf and similar groups at the branch level to act independently with respect to finances and accounting, without requiring the use of a SIR EIN and without audit, under the direction of branch members participating in the group. Consistent with this practice, until further notice BEC acquiesces in the Branch 146 golf group having independent financing and accounting, without audit, and without an account using the SIR EIN, while recommending that the golf account have two Branch members named on the golf account(s). BEC unanimously approved this motion.

The sense of the BEC is that the golf group is essentially self governing and that the golf group (and not the BEC) should determine how to independently handle group finances.

Bob Ford undertook communication on this matter with the golf group.
