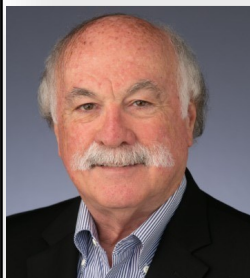

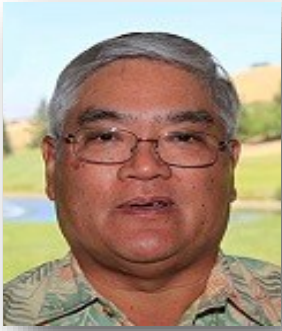
There is much more to come for the rest of the year, and we will keep you updated. We hope to see you in February!

The 2025 membership count is 263.

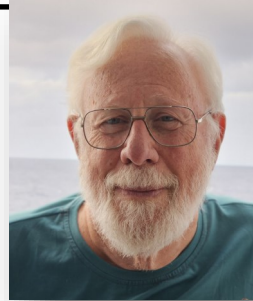

For our first trip of the New Year, six SIR birders spent a very pleasant morning along the edge of the Contra Loma Regional Park Reservoir, located in southern Antioch. During our leisurely

walk along the lake, we had close and lengthy looks at 33 species of birds. There were many highlights, including 22 Snowy Egrets, 21 American White Pelicans, and several looks at a very cooperative Osprey. In addition, we heard the distinctive calls of 2 Soras and 2 Marsh Wrens, and good looks at a rarity, a Tricolored Blackbird.

Our next field trip is scheduled for the morning of February 10th (2nd Monday) at Heather Farms. This trip will be ideal for beginners and seasoned birders alike. There have been Green Herons, Black-crowned Night Herons and Hooded Mergansers sighted recently. Heavy rain cancels. All levels of birders are welcome plus I have a few loaner binoculars I can bring if notified before the trip. If you have an interest in participating in this hiking activity, please let me know and I will add your email address to my distribution list.

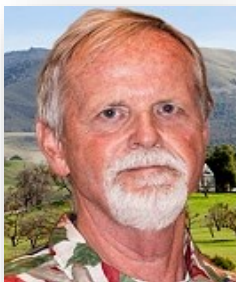

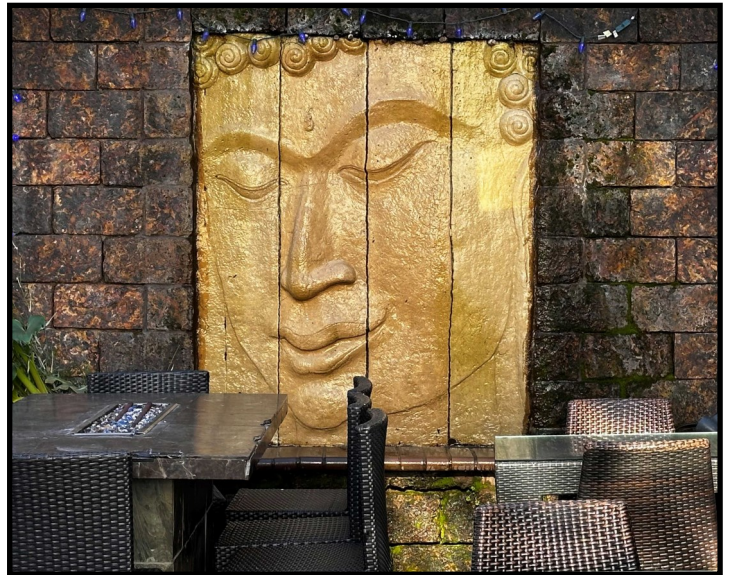

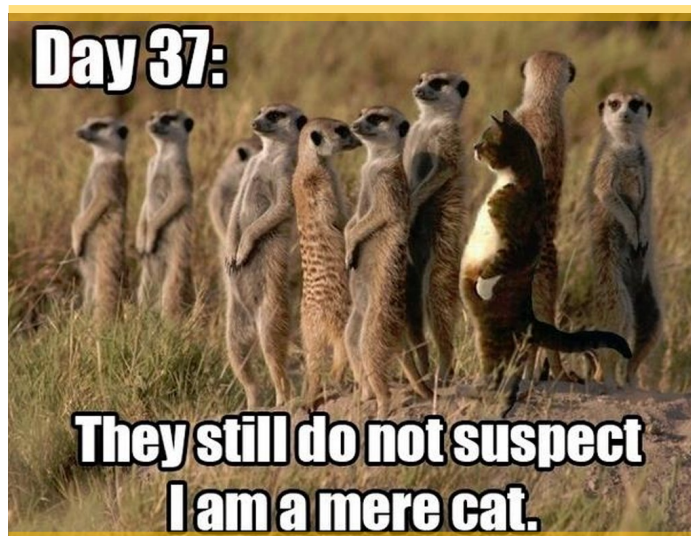

REPORT FOR JANUARY

The Sir 146 Book group held its year-end meeting in December and reviewed the book of the month, "Keeping the Faith:

God, Democracy, and the Trial That Riveted a Nation," by Brenda Wineapple.

In her book that focuses on two protagonist famous lawyers, Brenda Wineapple masterfully reconstructs the 1925 Scopes Monkey Trial, a landmark legal battle that pitted modern science against religious fundamentalism in the heart of rural Tennessee. The name "monkey trial" stems from the claim that evolutionists believed that humans descended from monkeys.

While the trial itself is a well-trodden historical subject, Ms. Wineapple's work distinguishes itself by delving deeply into the lives and motivations of the two central figures: Clarence Darrow, the renowned defense attorney and agnostic, and William Jennings Bryan, the three-time presidential candidate and devout Christian fundamentalist. Through meticulous research, she paints a portrait of these two titans that reveals not only their opposing worldviews but also the complex social and political forces that converged in the sweltering Dayton courtroom.

Clarence Darrow, a Chicago lawyer with a national reputation for defending the underdog, emerges in Ms. Wineapple's narrative as a complex and often contradictory figure. Known for his passionate advocacy for labor rights and his staunch opposition to capital punishment, Darrow was a champion of individual liberty. He viewed the Butler Act, the Tennessee law prohibiting the teaching of evolution in public schools, as an egregious violation of academic freedom and a dangerous encroachment of religious dogma into the realm of science. The author emphasizes Darrow's deep skepticism, his rejection of organized religion, and his belief in the power of human reason to solve the world's problems. But he had his contradictions. Although he represented John Scopes on a pro bono basis, he was not

above charging huge fees to other clients, including the wealthy families of Nathan Leopold and Richard Loeb, two bright Chicago teenagers who murdered a friend just for the fun of it. But he did save the pair from execution. He was also charged with bribing a witness in a trial in Los Angeles, a charge that Ms. Wineapple states may have been valid.

Ms. Wineapple skillfully weaves together the lawyer's personal history with his public persona, revealing the influences that shaped his worldview. She explores his early life in rural Ohio, his brief stint as a lawyer for the railroad, and his eventual embrace of progressive causes. The book highlights his remarkable ability to connect with juries, his talent for crafting compelling narratives, and his unwavering commitment to defending unpopular clients, which were his standard fare.

In contrast to Darrow's skeptical and often pessimistic outlook, William Jennings Bryan embodied a fervent and unwavering faith. A charismatic orator and populist politician, Bryan ran unsuccessfully for president on the Democratic ticket three times. In many ways, he was like Darrow and Darrow voted for him twice. Bryan championed the cause of rural America, advocated for social and economic reforms, supported women's suffrage, and consistently challenged corporate greed. But he was also a racist and his dislike of corporate greed did not extend to promoting watery Florida real estate, where he made a fortune. But his defining characteristic was his deep commitment to his religious beliefs, viewing the Bible as the literal and infallible word of God. He saw the theory of evolution as a dangerous assault on Christian morality and a threat to the very foundations of American society. For Bryan, the Scopes trial was not merely a legal dispute but a moral crusade, a defense of traditional values against the encroaching forces of modernism.

Ms. Wineapple delves into Mr. Bryan's background, exploring his upbringing in a devout Presbyterian household, his early career as a lawyer and politician in Nebraska, and his rise to national prominence as a champion of the common man, and the publisher of his newspaper, "The Common Man." She highlights his remarka-

ble oratorical skills, his ability to captivate audiences with his powerful and emotive speeches, and his deep connection to the religious sentiments of rural America. He was a man driven by a profound sense of moral duty, a belief that he was called to defend the Christian faith against the perceived threats of secularism and scientific progress.

The clash between lawyers Darrow and Bryan in the Dayton courtroom was not just a clash of legal arguments but a clash of worldviews, a microcosm of the larger cultural and intellectual conflicts that were reshaping American society in the 1920s and which are reappearing today. Ms. Wineapple vividly recreates the atmosphere of the trial, the sweltering heat, the throngs of reporters and spectators, and the intense media attention that transformed the small town of Dayton into a national stage. She meticulously details the legal proceedings, the arguments presented by both sides, and the dramatic moment when one of the lawyers, Clarence Darrow, called the other, William Jennings Bryan, to the stand as a witness on the Bible.

This cross-examination, perhaps the most famous episode of the trial, is given particular attention by the author. She portrays it as a pivotal moment, not just in the trial itself but in the broader cultural debate over science and religion. Darrow's relentless questioning exposed Bryan's limited understanding of scientific concepts and his reliance on literal interpretations of scripture. While Bryan maintained his unwavering faith, the exchange revealed the inherent tensions between a literal reading of the Bible and the findings of modern science.

Ms. Wineapple avoids simplistic portrayals of Clarence Darrow as the hero of reason and William Jennings Bryan as the villain of religious fundamentalism. She presents both men as complex and flawed individuals, driven by their own deeply held beliefs and shaped by the social and political forces of their time. By exploring their backgrounds, their motivations, and their interactions, Ms. Wineapple provides a nuanced and insightful account of the Scopes

trial and its enduring significance in American history. "Keeping the Faith" is not just a retelling of a famous trial; it is a profound exploration of the enduring tensions between faith and reason and tradition and modernity as the real story that continues to shape American society today. It is a testament to Ms. Wineapple's skill as a historian and her ability to bring the past to life with vividness and insight.

Our sole caution about the book is that it is overly scholarly, and we found the approach toward history as seen in Erik Larson's books more suitable. The themes argued in the courtroom in Dayton are still being argued today. Read this book with an open mind, particularly if one is interested in the trial and the two famous protagonists.

Our next meeting will be at 8 am at the Panera Restaurant in Walnut Creek on January 27. We will be discussing "Lazarus Man", by Richard Price, which is our next monthly selection.

Note: This will be my last report as Nick Jabuka is taking over as Chair next month.

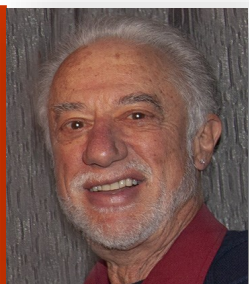

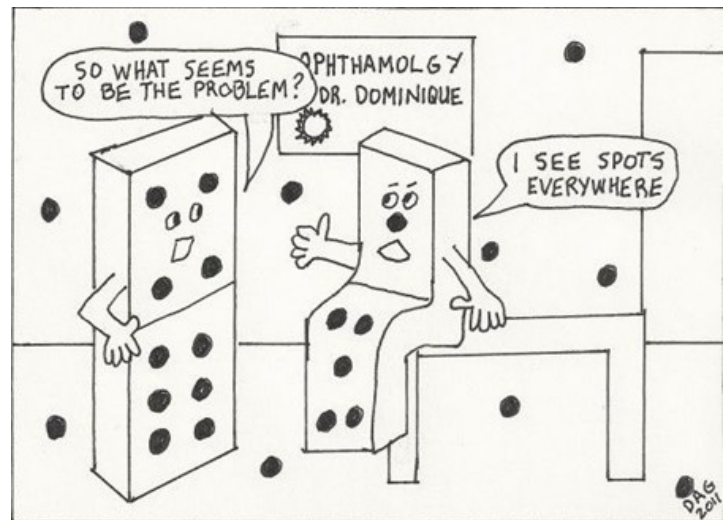

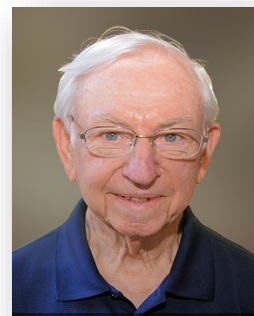

Couples Duplicate Bridge 2 Dave Pierce

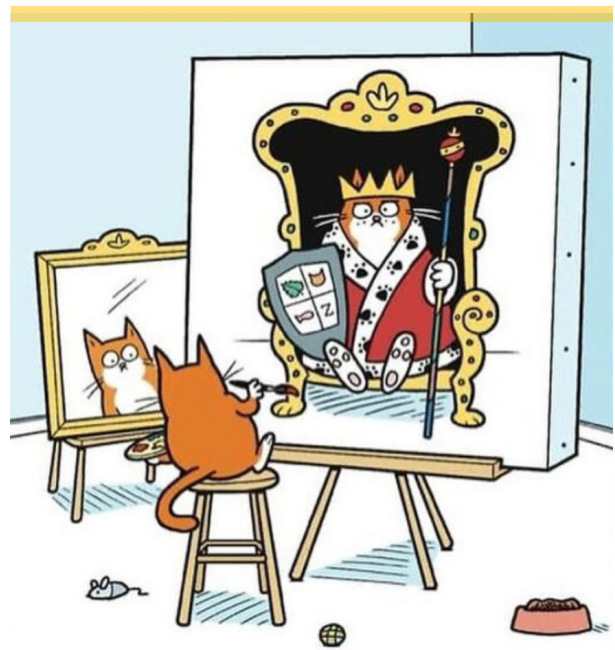
